ECC does not assume any liability for damages resulting from the temporary unavailability of the ECC FTP.

The contents of the ECC SPAN<sup>®</sup> parameter file - e.g. product details, parameters and prices - remain property of ECC. The ECC SPAN<sup>®</sup> file and its contents may be used for distribution to ECC clearing members or for performing calculations for ECC clearing members only. Distribution or duplication of the ECC SPAN<sup>®</sup> parameter file or the information contained therein - in total or parts of it - for any other purposes is prohibited.
