With this application form you can apply for admission as a Non-clearing Member (NCM) at European Commodity Clearing AG (ECC) according to the Clearing Conditions of ECC. NCMs are companies without a clearing license, which take part in clearing as clients of a Clearing Member on the markets for which ECC provides clearing services. Further details regarding the legal relationship between the parties are provided in the Clearing Conditions of ECC.

Central Coordinator

The person listed below shall be appointed as Central Coordinator to act as the main contact person for clearing related membership matters and – provided that the member is also a member of European Energy Exchange and/or European Energy Exchange AG (both hereinafter referred to as EEX)³ – exchange related matters. The role as Central Coordinator includes for example managing access to digital platforms of ECC and EEX, where the Central Coordinator can configure technical infrastructure, nominate deputies, and initiate changes of responsibility directly within such digital platforms. The Central Coordinator is empowered to act on behalf of the member for administrative requests.

The Central Coordinator

- I. shall be responsible for the internal distribution of all information related to ECC and – where applicable – EEX,
- II. shall, by default, have the power of attorney to represent the member and to issue declarations and provide signatures on behalf of the member vis-à-vis ECC in all clearing membership related matters and – where applicable – vis-à-vis EEX in all exchange related matters,
- III. will receive access to the Member Section and the Customer Portal and may administrate the user accounts and assign rights therein, in particular appoint a deputy who has the same rights and power of attorney as the Central Coordinator and
- IV. shall also act as the designated contact person and authorized signatory for the KYC review process, in accordance with the current ECC Clearing Conditions and the German Anti Money Laundering Act (Geldwäschegesetz).

It is mandatory to name **one personal** business E-mail address (no privately used, departmental or group E-mail address).
