Technical changes due to the merger of Powernext into EEX

Summary

The European Energy Exchange (EEX) has successfully integrated Powernext and Gaspoint Nordic as of 1 January 2020. In this Clearing Circular, ECC provides information regarding the last technical changes in our settlement system (SMSS). Those changes are reflecting the new legal set up and will be active as of **26 May 2020**:

- Update of SMSS Product Group names including renaming of NCG-L locational products
- Adjustment of SMSS Limit Definitions

Update of SMSS Product Group Names including renaming of NCG-L locational products

The Source PWX in all trades conducted at EEX will be converted to EEX. The prefix PWX in each Product Group name will be replaced by EEX.

 For example, Product Group name PWX_ST_NATGAS_TTF will change to EEX_ ST_NATGAS_TTF.

Due to renaming of locational products Elten and Vreden to NCGL_WEST and NCGL_EAST the delivery point and the affected Product Group names will be changed respectively.

- For example, Product Group name PWX_ST_NATGAS_VRE will be changed to EEX_ST_NATGAS_NCGL_EAST.

With the update all SMSS reports will be using the new Product Group names. Please follow the following example for the Trade Report:
