
## **Change of IP Address of ECC Member Area**

Due to ongoing improvements, we will migrate the ECC member area to a new IP address. From **31.01.2022** onwards the simulation environment of the ECC member area with the URL **smsssimu.ecc.de** will be mapped to a new IP. Further, from **22.02.2022** the production environment of the ECC member area with the URL **smss.ecc.de** will be mapped to a new IP.

To test your network setup, a dedicated URL was prepared pointing to the new IP of the simulation environment. Each user can test if the new IP address is accessible by clicking on the following Test-URL:

The Test-URL leads you directly to the simulation environment of the ECC member area. We kindly ask you to click the above URL and check if you are forwarded to the simulation environment of the ECC member area which looks like this:



If you are forwarded, the test is successful and we do not expect any issues with the change of the IP addresses of both URLs.

### Preparation for migration of ECC Member Area Reporting SFTP Server

As part of the improvements, the SFTP Servers **ftps.ecc.de** and **ftpssimu.ecc.de** will be moved to a new data center in Q2/Q3 2022 and IP addresses will change too. The date and necessary actions will be announced in advance of the migration and no action is necessary right now. However, to support the process and reduce effort on your side, we recommend the following preparation step:

In case you or your application accesses our SFTP server directly by using their public IPs, we advice you to switch to use their domain names instead.

If you call our SFTP server via 85.239.110.88 à please use **ftps.ecc.de**If you call our SFTP server via 85.239.110.92 à please use **ftpssimu.ecc.de** 

Please note, both calling methods remain valid until further notice.
