Process and Product Details

EEX and ECC intend to introduce a general admission covering all financial power products settled in EUR that may be traded and registered at the EEX. This will provide you the possibility of an access to the whole range of power products. A separate admission process for trading additional financial power products is no longer required. There are no costs involved in this planned change.

Currently this includes the below-mentioned financial power futures offered at EEX for exchange trading and trade registration setup as follows within the ECC clearing system (SMSS):
